Contributions to Pawlenty for President are not tax deductible for federal income tax purposes. Contributions to Pawlenty for President will be used in connection with federal elections and are subject to the limitations and prohibitions of federal law. The maximum an individual may contribute is \$2,500 for the primary election and an additional \$2,500 for the general election. Couples may contribute up to \$5,000 for each election; joint contributions require the signature of both spouses. Federal multicandidate PACs may contribute up to \$5,000 for each election. Contributions from corporations, foreign nationals, and federal government contractors are prohibited. Contributions must be made from personal funds and may not be reimbursed by any other person. Federal law requires us to use our best efforts to obtain and report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in an election cycle.
